Institutional Support Grants for Long-term Conceptual Development of a Research **Organisation**

- (1) The Institutional Support Grant for Long-term Conceptual Development of a Research Organisation (hereinafter referred to as "Support Grant for LCDRO") is awarded to MENDELU in accordance with Act No. 130/2002 Coll. on Support of Research and Development from Public Funds and on Amendment to Certain Related Acts (the Support of Research and Development Act), as amended, by a decree of the Ministry of Education, Youth and Sport (MŠMT) in accordance with its established rules.
- (2) The Support Grant for LCDRO will be divided into five parts according to the percentages listed for the given criterion (definitions of the criteria are provided in paragraph no. 3)

a)	MENDELU point	70%
b)	External national projects	10%
c)	External international projects	10%
d)	Contractual research	5%
e)	The Gregor Johann Mendel Grant Agency	5%

- d) Contractual research is defined in accordance with article 2.2.1 of the Community Framework for State Aid for Research, Development and Innovation 2014/C 198/01 as the volume of funds allocated to MENDELU in 2015–2018 for research performed for a specific enterprise as a service multiplied by the coefficient regulating the field specifics of the research.
- e) The Gregor Johann Mendel Grant Agency is defined as an internal grant agency which will award grants for projects in the defined categories via the Council for International Multidisciplinary Collaboration.
